- J. RECONVENE INTO REGULAR SESSION
- K. COUNCIL COMMENTS Ryder expressed her excitement over the upcoming Christmas Tree Lighting at City Hall. Glick commented on the water well issues. He also commented to Mike Anderson, BEDC director, that he was glad to see the increase in activity in the downtown area due to promotion of businesses. He also expressed his appreciation to the Hammond's, who own property in that area, for investing in the downtown area. He also asked if the City had heard from TX DOT about future road expansion in the downtown area and how it might impact our revitalization projects.
- L. MAYOR COMMENTS- Reminded all of the Christmas Tree Lighting Event being held November 29, 2021 and the Holiday Havoc Wrestling Event being held on December 11th to benefit the Harriman Park Restoration Project. He commented on the turnout for the Chamber of Commerce's BBQ Cook off. Nineteen teams attended and only 2 were locals. He was approached to do a

state cook off in the future due to the positive comments on the Leon County Expo Center. He also mentioned that the BEDC owned lot downtown may be an extra source of parking in the future if they decide to develop it. His final remarks were that December was going to be busy month for him and he would not be in attendance at the monthly council meeting.
